



## PACKAGING DATA FILE

This document describes the general conditions that must be maintained in order to make the most out of our products. Eurobottle has the intention to inform you according to her best knowledge and experience. Specific application may vary and require specific instruction. Eurobottle can never be held responsible for incorrect use of their products.

### Storage conditions

Store pallets 1 level high in a clean, dry area and away from UV-light, smell and high temperature variations for a maximum of 12 months from delivery date. The maximum storage temperature for our products is 35 degrees Celsius.

### Traceability

All products delivered by Eurobottle carry a batch code on the bottom of the bottle. This code refers to the date of production. Please use item and ordernumber and batch code in your communication with Eurobottle. Tracing is not possible without this batch code.

### Food safety

Flethic, the manufacturing company of Eurobottle, is certified according to the ISO 22000 standard for food safe production and we fulfil the directive 2023/2006 (GMP). Contact your sales representative if the product is suitable for the intended use and if it is evaluated for use with food products according to 10/2011/EC.

### Bisphenol A

Every Eurobottle bottle is free of Bisphenol A.

### REACH

We are aware of the REACH Regulation (1907/2006) and sufficiently trained. The registration requirements (article 6 and 7) do not apply to our work. We are a manufacturer of products and source our raw materials only from within the EU. If there is a situation of use of SVHC substances, then we (as a downstream user) will be informed by our suppliers. We will contact you (as a downstream user of Flethic), within 45 days and meet the notification requirement (as stated in article 33, version 10/04/2014).

### When using

Rinse the product with warm water before and after every use. A dishwasher can be used for intensive cleaning of the bottle and cap. To avoid any risk of damaging the bottle, it is our advice not to place it in the hottest sections of the dishwasher. Store your bottle, after cleaning, in a dry and safe place with the cap open. This allows the bottle to dry well and it avoids an unpleasant smell and taste of plastic.

### Do not use

Do not use the bottles for hot liquids. Liquids hotter than 40 degrees Celsius can have a detrimental impact on the functionality of the bottle and could harm the safety of human beings. Also do not use this bottle for carbonated drinks. Due to internal pressure leakage can occur.
